1. That the statements made and information furnished in the application and all other enclosures connected thereto are true. Should it however, be found that any information furnished therein is untrue in material fact and particulars, I am liable for criminal prosecution and forfeiture of the seat in institution irrespective of the fact of the period I have spent for the course.
2. That I am to confirm strictly to all the rules and regulations in force now and which may be introduced by the authorities in the institution hereafter and that breach of discipline and rules on my part, would entail summary forfeiture of the seat in the institution.
3. That if I do not fulfill in the minimum of 80 percent attendance in theory and practical separately for each course, I would become disentitled for final theory and practical examination respectively in the courses.
4. That in case of my performance/progress in studies is uniformly poor in institution, I am aware that authorities concerned, will initiate action against me for termination from the course, by issue of transfer certificate.
5. That breach of discipline both in and outside campus and rules of bad conduct in the curricular or extracurricular activities or breach of discipline during study tours will also entail summary forfeiture of my seat in the Institution, in addition to such other proceedings as it may deem fit and warrant, will be taken against me.
6. That if I am admitted in to the hostel as an inmate, I shall have to abide strictly by the rules and regulations in force in the hostel and that any breach of discipline or rules or any unruly conduct or undesirable activities will be seriously dealt with by the forfeiture of seat both in hostel and the institution

in addition to such other proceeding that are to be against me as per rules and regulation of the university or as per law.

7. That I am aware that involvement in ragging of course student(s) and report if any made against me by the affected, in respect of the same, I will be summarily dismissed by the authorities of the Institution both from the Hostel and the University.
8. That I shall abide by the orders of the authorities of the University to pay the tuition and other fees as prescribed/revised from time to time.
9. That in case of discontinuance, I am aware that only eligible amount of caution money deposit alone will be refunded.
